Discovery the offender, for claims arising from tort. The limitation period starts to run from the date on which the relevant right arose or, in tort, when the injured party is in a position to know of the damage and of the author of the damage. Claims arising from latent defects:

Forexample, New York requires claimant to file breach of oral or written contract

If an action is not brought within the applicable limitation period, the claim will be forever lost. Identification of the defects. Five years for claims by employees, attorneys, doctors and for most periodic payments.

Tort excluding personal injury, libel and slander where the time limit is reduced to five years. five-year prescription period applies to contract claims and claims in delict, as well as certain tenancy matters. Comply with policy requirements.
